## <u>Sub: Outcome of Circular Resolution passed by the Nomination, Remuneration and Compensation Committee</u>

Dear Sir/Madam,

This is to inform you that the Nomination, Remuneration and Compensation (NRC) Committee of the Board by way of Circular Resolution on 17<sup>th</sup> July, 2025 have inter alia transacted the following business:

1. Approved allotment of 16,300 Equity shares of Rs.10 each under ESOP-2007 scheme and 81,510 Equity shares of Rs.10 each under ESOP-2018 scheme to the eligible employees of the Company on exercise of stock options vested in them.

Consequently, on allotment of equity shares under ESOP Scheme-2007 and ESOP Scheme-2018, the issued, subscribed and the paid-up Equity Share capital of the Company has increased from 2,54,82,204 Equity shares to 2,55,80,014 Equity shares of Rs.10 Each.
